## Time is Running Out

If you are a mortgage originator and haven't already taken the SAFE Act-required State and National tests, the deadline is fast approaching. If you are licensed by the DRE, you should take the tests before August 31, 2010 in order to acquire the endorsement so you can originate loans after January 1, 2011. Under the DOC, you should have already taken both the State and National tests! Check out both the DRE and DOC websites for more information about the timing and requirements.

# Training is Needed

The tests are hard, and I should know — I helped write both the California exam and the National exam. After months of committee work, we came up with very comprehensive tests. And if you don't pass, you have to wait 30 days before you can retake them. If you fail repeatedly, you then have to wait SIX MONTHS before being allowed to retake them. So, in order to be sure you won't be left high and dry, you should train carefully and then take the tests as soon as possible.

# Online Class Available
